# 4. Matters Arising from the Minutes RESOLUTION 22/12

Members **RESOLVED** to purchase an additional Dog Waste Bin (Retriever 35) to be installed at the north end of the Village.

## Reports from County and District Councillors Cllr Shaun Parsons (GCC)

- There had been a road safety meeting today and there is much support developing for reducing the speed limit on the toll bar.
- Cirencester Town Council is very active in controlling the flow of water in the Churn and the Environment Agency is carrying out a study. The River is currently lower and there is some evidence that some dredging has been done.
- Ownership of land near to Tesco has not yet been identified.
- £10,000 will be available to each County Councillor for use on Highways projects. Cllr Mrs Chester-Master asked if a contribution could be made to a speed survey on the Toll Bar as CTC is willing to contribute.
- It was noted that residents believe there to be far more accidents at Toll Bar that are not reflected in the data.
- It was noted that some residents took compensation due to the noise level on A417/419 caused by the road surface. Cllr Parsons advised that give the current austerity it is unlikely that anything will be done at the moment at that it may have to wait until the 30 year use is up when the surface will be reviewed. Will try to keep it as a standing item for Highways meetings.

## Cllr Clive Bennett (CDC)

- Confirmed that the flooding at Kingsmeadow picnic area is being monitored and that CDC has removed some debris.
- He believed that 2013 is the earliest that anything can be done about the A417/419 road surface and explained that Geoffrey Clifton-Brown MP has stated that there is no funding available to resurface unless it is worn. However, the surface is very hardwearing and unlikely to be in need of repair although it is noisy.

## Cllr Juliet Layton (CDC)

Advised that the A417/419 Group is very active and noise levels are monitored but acknowledged that there is no funding available to resurface and that the Group needs

## **Community Speed Watch**

Cllr R Canton reported that there are 5 local volunteers to carry out speed monitoring and that Andy Fodgen has recommended progressing this in March / April when the weather is likely to be better and the equipment will be available.

## Highways – A419 Preston Toll Bar

The Clerk advised that Gloucestershire Highways does not object to the proposal to reduce the speed limit on the A419 and including the Cirencester inner ring road. However, the need must be justified by first monitoring current traffic speeds which is estimated to cost in region of £3,000. Highways are looking to those Parishes affected to make a contribution to the cost and the Clerk at Cirencester Town Council has indicated that the Town Council would be prepared to do so. It was agreed in principle to make a contribution to this cost and Cllr Parsons was asked if he would make the Parish Council's contribute from the £10,000 that he has available to enhance partnership working in his Division between Parish Councils and Highways. Cllr Price agreed to check the proportion of the road in Preston
