6. Report from County and District Councillor – Cllr Shaun Parsons

- Budgets at GCC and CDC have been finalised.
- Pleased that Preston is using GCC's Active Together Fund to replace play equipment
- Highways Roads in a terrible condition but will receive additional £2.5 m from national government and trialing new techniques for repairs.
- Lost £34m in budget cuts.
- Parts of the A429 Lechlade road will be re-surfaced in next 6 months
- CDC is funding improvements to the broadband service
- Unitary with West Oxfordshire Proposal Main office is likely to be in Witney. Gloucestershire devolution will still go ahead.
- Chesterton development is also likely to go ahead and is in the local Plan.
- Additional sewerage works will be carried out in connection with the Bloor Homes development at Siddington.
