Cllr Price reported that parts of the field will definitely need re-seeding and it was agreed that he should proceed at the appropriate time and after spraying the weeds first.

It was noted that the old safety surface where the old slide was located needs to be removed.

Traffic Speed and to Consider Installation of an Automatic Number Plate Recognition device – Email from Mr A Stone

The Council debated Mr Stone's request for the installation of an ANPR camera to address speeding issues as it had been reported that both Siddington and South Cerney Parish Councils were doing so,

The Clerk reported that Siddington and South Cerney are in the early stages of considering the installation of these cameras and, therefore, there is no further information at this time.

It was noted that no other requests or complaints about speeding in Preston have been received and in view of the cost of the equipment and difficulty in finding a suitable location, it was agreed to wait and see how the other two Parish Councils proceed.

Action: It was further noted that 30 MPH sign opposite Village Farm has been knocked over and the sign has disappeared. The Clerk was requested to notify Gloucestershire Highways.
