13. Planning

13.1 New Planning Applications

22/01203/FUL. Preston Court Siddington Cirencester Gloucestershire GL7 6ET

Erection of side extension to garage. Conversion of first floor of garage into study. Insertion of two windows and three rooflights.

RESOLUTION 25/22

The Parish Council strongly objects to this application on the following grounds:

- The proposed change to the garage has the potential to become a domestic building which could be used as an annexe or separate house.
- The Parish Council is concerned about possible subdivision on this site which could result in an increase in the number of vehicle movements to and from the

- site. It is on a busy stretch of road where there has already been a significant number of serious road traffic accidents.
- The garage will overlook the garden of the neighbouring property where screening is not possible due to the listed weir.
- Concerns about light spill over the river which was one of the key conditions of the permission attached to the original application.
- Concerns that many of the trees and much of the vegetation has been removed from the riverbank by the applicant. Not only is there concern about the loss of these trees in themselves but also the impact of loss of the root ball in stabilising the riverbank and its effect on the local ecology and biodiversity. In addition, the applicant is now unable able to comply with conditions previously imposed and agreed relating to the safeguarding of local biodiversity i.e., nesting platforms for swallows, bat and barn owl boxes etc.
- This application, as with previous applications, is inaccurate and misleading
 e.g., the drainage drawing submitted is the same as the original application
 which has since been amended.
- There are window openings shown on the western gable elevation of the garage. However, the applicant has already been instructed by CDC to infill these with cladding to match.

The Parish Council appreciates that CDC is unable to prevent the submission of multiple applications, but we are extremely concerned that each application for this site is ambiguous and inaccurate. The lack of continuity from planning staff has exacerbated the problems and resulted in errors being overlooked and enforcement not being carried out thoroughly.

New Premises Licence

The Parish Council made the following comments in relation to this Licence application:

- 1. The main problem is going to be getting vehicles in and out, principally out. There is no proposal in the traffic management plan to include traffic lights but we would expect Stewards to be positioned at the road junction(s) to assist vehicles.
- 2. The organisers expect the visitors to use public transport, but we are not aware of any that service this road.
- 3. The application refers to a new railway station called Little Kimble from where a shuttle bus service will run! The organisers should be asked to identify the location of the station!
- 4. The event occurs between 21 and 24 July. This is one of the busiest, if not the busiest, weekends of the year as it is the start of most school holidays. This is likely to result in significant congestion at the Burford Road junction on the A417 and the traffic lights at the junction of the A429 and B4425. This does not appear to have been addressed.
- 5. In Section 1 of Appendix E the applicant states that the event will start on 21 July and end on 24 July. In Section 2 they state that "at the end of the event the majority of attendees will stay on site in the campsite and live-in vehicle area". This suggests that attendees will still be on site well after the official end of the event. This needs to be clarified.
- 6. In Section 12 of Appendix E they advise that: there is no need for traffic management on the public highway and the main entrance is on the beach!
- 7. This demonstrates that the organisers have clearly not considered the Traffic Management Plan in relation to this site.

With these comments in mind, the Parish Council does not support this application and hopes that it will be rejected in its current state.

The application had been approved by CDC but the Parish Council's comments had been passed to the applicant.

21/01532/FUL. Norcote Grange Norcote Cirencester Gloucestershire GL7 5RJ
Change of use of former stables to tourist accommodation together with associated ancillary works including creation of new access from private drive
The Parish Council objects to this application and feels that the comments made about the previous application still stand:

- There are already 11 residential properties exiting this site on to the A417 London Road at the same place. Although the no of additional properties has been reduced to 2, they will still be able to accommodate the same number of people and, therefore the traffic hazard concerns remain.
- The proposed arrangement which include communal areas, would attract party groups which have the potential to be very noisy, disturbing the occupants of neighbouring properties, impacting on their privacy and changing the whole dynamics of the site and are out of character in this quiet rural residential retreat. The Parish Council supports the Pollution Officers comments relating to noise and disturbance.
